Complete and sign this form to request exemption from Nonresident Supplemental Tuition charged to nonresident students. Once determined to be eligible, you will continue to receive the exemption as long as you fulfill eligibility requirements or until the University no longer offers this exemption. Applying for this exemption does not in any way alter your responsibility to pay, by the campus deadline, any Nonresident Supplemental Tuition and associated fees that may be due before your eligibility is determined. Submit the completed and signed form, with transcripts, to a UCLA Residence Deputy at the Registrar's Office, 1113 Murphy Hall, Box 951429, Los Angeles CA 90095-1429.

Application

I, the undersigned, am applying for a University of California Nonresident Supplemental Tuition exemption and declare that the following apply to me.

Check one box only.

- I have a current visa as defined by federal law
Nonimmigrants have been admitted to the U.S. on a temporary visa and include, but are not limited to, foreign students (holding F visas) and exchange visitors (holding J visas).

This includes, among others, U.S. citizens, permanent residents, DACA recipients, and individuals without lawful immigration status.
