

REGISTRATION AND MISCELLANEOUS FEES

FEES are subject to revision without notice

University Fees

No part of these fees is remitted to students who may not desire to make use of any or all student privileges. The University will pay interest in the amount of \$2.25 for the registration fee overpayment in Fall Quarter 1993. Students who receive financial aid or graduate fellowship waivers for full fees are not eligible for this interest payment. The interest payment became available on existing or new ASUCLA Bruin Gold Card accounts in early November. Fall Quarter 1993 graduates are eligible for a \$122 refund which will be mailed by April 1994. If you graduate in Winter Quarter 1994, you will be eligible for a \$61 refund which will be mailed by June 1994. If you do not attend in Winter Quarter 1994, you will be eligible for a \$61 refund which will be mailed by mid February 1994. If you do not attend in Spring Quarter 1994, you will be eligible for a \$61 refund which will be mailed by mid May 1994. Fall Semester 1993 graduates and students who do not attend Spring Semester 1994 will receive the same interest payment (\$2.25) and a refund of \$182.50 which will be mailed in mid February 1994.
